We all love Darling Harbour, but now it is under threat from heavy over-development!

We all love Darling Harbour. Why?

- Because it is an oasis of sunny open space, sparkling water and low-rise amenities in the centre of the city.
- It is a playground for families in a city whose foreshores are often crowded out with tall buildings that block our sun and views of the harbour.
- Yet worse will be the towering twin skyscrapers of a 900-bed hotel crammed between the Novotel and Harbourside building, casting its long shadows over Harbour and restaurants, and transforming our friendly, human-scale Darling Harbour into yet another hole full of shadows loomed over by giants.

People are protesting this re-development for the following reasons:

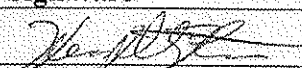
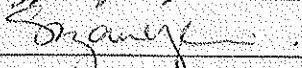
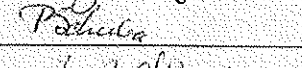
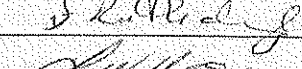
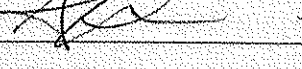
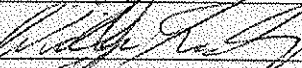
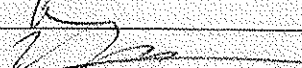
1. Overshadowing: The twin towers of the proposed hotel will cast huge shadows over Darling Harbour, making its open spaces feel oppressive and undermining the human-scale concept of the entire area.
2. Destruction of two iconic building: The Convention Centre was designed by a world-respected architect, John Andrews. The proposed height of the new convention centre is 47m, while Sydney Council's guideline was for 29m. The Exhibition Centre was designed by Philip Cox and won the 1989 Sulman Award. It will be knocked down.
3. Loss of easy access to Darling Harbour: The footbridge across the light rail and into Darling Harbour is used by thousands of residents, tourists and business people each day. It appears it will be gone.
4. Loss of access to Pyrmont due to changes to Darling Drive: The reduction of Darling Dr. from two lanes each way to one lane each way must significantly increase traffic problems for people trying to get to Darling Harbour.
