Dongmun Greentec Pty Ltd has submitted a development application (DA) for the Deniliquin Ethanol Plant, located at Lot 234, 272 and 273 in DP 756325 on Deniliquin Barham Road, Deniliquin in the Deniliquin Local Government Area. The proposal involves construction and operation of an ethanol production plant and associated infrastructure. The plant will have a capacity to produce 115 megalitres of ethanol per annum, and will include grain storage silos, on-site ethanol storage, a wastewater treatment facility, workshop area, training and development centre, car parking, internal road network and associated stormwater infrastructure. The facility meets the criteria as a Major Hazards Facility based on the volume of ethanol to be stored on site.

The development application including the Environmental Impact Statement (EIS) will be on public exhibition **from Tuesday 13 October 2015 until Thursday 12 November 2015**.
