Boggabri Coal Project Modification (09_0182 MOD 2) Response to exhibition of Environmental Assessment Comments by NSW Office of Water

Water Supply:

The proposed modification involves the processing of Tarrawonga coal at the Boggabri infrastructure facilities, which will increase the water demand at Boggabri Coal Mine. The Environmental Assessment (EA) outlines the annual water demand for Boggabri Coal will increase by up to approximately 700ML as a result of the proposed modification. The EA outlines both Boggabri Coal and Tarrawonga Coal will use their surface water and groundwater licences to meet external make up water supply requirements. Both mining companies will need to ensure they have appropriate licences to cover any water shortfall associated with the proposed modification, and if needed acquire additional licences to ensure they have the allocation required for the operations.

Sediment Dams:

The NSW Office of Water notes that the EA for the proposed modification outlines the requirement to modify existing sediment dams on the Tarrawonga site and that sediment dams will be increased or decreased in size and some sediments dams will be relocated to construct a haul road and diversion drain. A new 50ML sediment dam will be constructed on the Tarrawonga mine site to capture runoff from the Tarrawonga northern emplacement. The EA also outlines that contaminated water taken from the sediment dams is utilised on site for dust suppression and make up water at the Coal Handling Preparation Plant. It is important that the use of water from sediment dams is appropriate and in accordance with the Harvestable Rights Order published under section 54 of the *Water Management Act 2000*.

Groundwater:

NSW Office of Water notes additional groundwater impacts have been predicted in the EA as a result of the proposed modification as there are no changes to mining. However additional water will be extracted from groundwater licences already owned by the companies.
