Hi Carel,

As per our discussion in DAP on Friday 25/6/21. Council's Engineers have comments relating to the proposed development, as provided below:

Concerns are raised regarding the ambulance access via Warrambool Street - particularly during school drop off/pick up times when traffic congestion is significant. Warrambool Street is a designated 40km/h school zone between 8am - 9:30am and 2:30pm and 4pm. While the Traffic and Parking Report indicates the peak afternoon period generally clears with 20 minutes - the potential for emergency access to the ambulance loading area during that peak time is still possible and therefore raises a safety issue - especially when child pedestrian activity is evident.

A kerb side warning device (strobe light /bell or similar) indicating an ambulance is entering/exiting the relevant driveway should be considered as an additional warning system for pedestrians/drivers on Warrambool Street. Although emergency vehicles are fitted with warning devices that are used when

on urgent duty, a supplementary on-site cautionary device may provide road users in the area with advanced warning that an emergency vehicle is approaching/departing. This would also provide a warning to non-school related traffic such as those attending the Sacred Heart Church (funeral/weddings) or other areas of the hospital.

The parking and Traffic report also indicates that, *in an emergency situation, ambulance vehicles will* be operating their sirens which will give them right of way. While that is correct - the right of way approach only applies when it is safe to do so.

Consideration should be given to relocating the access to the ambulance loading area away from Warrambool Street based on the potential for vehicle/pedestrian conflict that may arise due to the proximity of the school, church and other hospital services. Should this not be practical - additional onsite warning devices as described above should be applied.

A suggestion is to redirect the existing accessway on Noorebar Avenue that currently provides for exit movements from the existing site (the accessway on Noorebar Avenue closest to Warrambool Street). Rather than making this accessway redundant, it should be redirected to act as a secondary entry/exit point for emergency vehicles that would primarily function during times of high congestion on Warrambool Street, (namely during school drop-off and pick-up hours and during weddings, funerals and other large events at Sacred Heart Church).

This would involve maintaining the current access point at Noorebar Avenue and linking it to the proposed emergency vehicle area by an internal accessway between the main parking lot and buildings 4 and 5.

This solution allows the current emergency vehicle entry/exit point to be maintained and utilised for most hours (when Warrambool Street is relatively quiet) while providing a secondary accessway that may operate during peak times and other times of congestion.

The access point off Noorebar Avenue would require adequate signage to indicate to the general public it is for emergency vehicle use only, and a sufficient analysis would need to be conducted to determine the best connection to the emergency vehicle bay.

This recommendation satisfies Council's concerns of emergency vehicle access from/to Warrambool Street during times of peak congestion.
