Dear Sir,

I am writing to You to Object to the Proposed Cobbna Coal Mine.

1. The close proximity to my own Property of the Proposed Cobra rail line, I have witten several letters(Registered mail) un answered Re my concerns ie, Dust and noise, and the Inability to cross stock to the otherside of my property due to the vastly increased rail traffic.

2. My property is included in the Exploratory mining lease and have been notified by mail of this fact acording to the map provided by the internet I am 1.86 ks from the proposed rail link construction.

3. The mines attttude to run roughshod over any one in the way.

4. Disruption of the underground water supply as of my sixteen dams 14 are spring fed the mine will use huge amounts of underground water, regaundless of the information the mine releases.

5. With regard to the weather information in particular the prevailing wind, information which states the winds are predomantly Easterly. why has the weather information from the Dunedoo Post Office which includes in particular wind Direction which would be the closest full weather information and shows as all of us locals in my case I or my family has been on this property for over seven decades is Predomantly north westerly there Eastly description is Blatent Lies.

6 In my case I have asked for pre Rail/mine noise and dust monitoring and have been dismissed out of hand

7. I note Mid western council has objected on at least one grounds ie the maintance of the now overburdened road system which I agree our council rates are stretched without the extra strain on many local Roads.

8. My neighbours Chris and Bruce Robinson Castlereagh Hwy, and Jim & Carol Burge Whistons Lane both of Tallawang have expressed to me that they hacc all been threatened with Aquisition if they dont sell to Cobbna Ho;ding this shows extremly poor form but tipical of other first hand storys I have been personally told I feel this situation needs further investigation mine marfia strike again.

9. Cobbna meeting held on the 14th May 2012 held in Gulgong High school Steve Ireland told me(Overheard By close neighbour) that Cobbna had just signed Next door neighbours Jim & Carol Burg at tallawang and Cobbna would give me access throuogh Hills now Cobbna Holding & then throuogh Burg but on speaking to Burgs they had not sold which to says the mine(Cobbna) are persuing The Divide and Conquer method of operation.

10. Further to weather comments(objections) the Gulgong Gliding Club keeps excelent records and have just told me there records indicate the prevailing winds are westerly to north westerly and are willing to Officially attest to this fact.

11. Surveying of the boundry between my self and my neighbours to the North J & C Burg was carried out on the Pretext of surveying of Hills Goldaringa Tallawang Jim Burg was asked to allow surveyors to survey the section between Hills and discovered the surveyas on our boundry fence without either of us giving permission.
