Reference is made to your letter dated 7 June 2012 regarding the subject development forwarded to Roads and Maritime Services (RMS) for consideration.

RMS has not had the opportunity to comment on the proposal since September 2011 when RMS advised the Department of Planning that additional information was required to make an informed assessment (see attached). RMS understands that the Upper Lachlan Council Local Traffic Committee (LTC) has had the opportunity to review the proposed Traffic Management Plan for the proposal and will be providing comments, including works required on classified regional roads.

Based on the above, RMS will not object to the development subject to the following comments being included in the conditions of development consent:

- Prior to transporting any oversized or over mass loads, the applicant shall obtain a permit for an oversized and over mass load from the RMS Special Permits Unit in Glen Innes. The contact number is 1300 656 371.
- The Traffic Management Plan (TMP) shall be revised by the developer to address any issues identified by the Upper Lachlan Council LTC. The revised TMP shall be resubmitted to the Upper Lachlan Council LTC for assessment and final acceptance.
- RMS understands that the TMP does not contain any Traffic Control Plans (TCP), RMS understands that development of TCP's is subject to the appointment of sub contractors for various construction and transport activities associated with the development. All TCP's should be presented to the Upper Lachlan Council LTC for consideration and acceptance then incorporated into the TMP.
- A copy of the accepted TMP shall be forward to RMS (via <u>development.southern@rms.nsw.gov.au</u>) prior to any transportation occurring or any works commencing on site.
- Concept plans for all roadworks on classified regional roads required as part of the accepted TMP shall be submitted to RMS for acceptance of the treatment type (via email to <u>development.southern@rms.nsw.gov.au</u>). The concept plans shall be accompanied by a copy of the accepted TMP.
- Once RMS has accepted the treatment types, the works shall be designed and constructed to the satisfaction of Council in accordance with Austroads *Guide to Road Design Part 4: Intersections and Crossings General* and Austroads *Guide to Road Design Part 4a: Unsignalised and signalised intersections*.

Note: Should the TMP identify physical construction works on the Hume Highway, RMS approval will be required. It should be noted that the approval process for such works may require the developer entering into a legal agreement with RMS, titled a Works Authorisation Deed. This Deed would manage the design and construction of the works. If physical construction on the Hume Highway is identified, the details must be forwarded to RMS for consideration via an email to <u>development.southern@rms.nsw.gov.au</u>.

 Should any roadworks require a reduction of the speed limit on the regional classified road network, a Speed Zone Authorisation shall be obtained from RMS Traffic Operations Unit (TOU) prior to commencing work within the classified road reserve. The requests shall be submitted to the RMS 10 business days prior to commencing work. It should be noted that receiving an authorisation within this 10 business day period is dependant upon the RMS receiving an accurate and compliant TMP. It should be noted that a Road Occupancy Licence from the RMS is not required for works on regional classified roads.

Conditions of development consent relating to road work, traffic control facilities and other structures on the classified road network contrary to those outlined above are unlikely to receive RTA consent under the Roads Act, 1993.

In accordance with Section 79C(1)(b) of the EP&A Act, Council as the Consent Authority, is responsible to consider any likely impacts on the natural or built environment in the road reserve fronting this proposed development. For instance there could be traffic noise impacts on adjacent residences, impacts on indigenous or non-indigenous heritage items or threatened species. RMS will not be making a separate Part 5 environmental assessment of the environmental impacts in the road reserve for this proposal.

Upon determination of this matter, it would be appreciated if a copy of the Notice of Determination could be forwarded to RMS within the appellant period for advice and consideration.
