The Office of Agricultural Sustainability & Food Security (O AS&FS) has reviewed the draft EA provided by Hansen Bailey dated February 2014. The only agricultural related issue is the high visual impact for road users and some of the rural residents in the Cullen Valley.

## Socio-economic assessment of the Coalpac Expansion Modifications (Invincible Colliery and Cullen Valley Mine Modifications) Draft Environmental Assessment

The Coalpac Expansion Modifications propose to modify current planning approvals for Invincible Colliery and Cullen Valley Mine. The Draft Environmental Assessment (EA) is adequate for public exhibition and for assessing the socio-economic impacts of the proposed modifications on agricultural resources and the agricultural community. However, it is recommended that the Draft EA be revised prior to going on public exhibition to address the concerns below regarding the mitigation and management of high visual impacts.

In Section 6.14.3 of the Draft EA, the proponent indicates that the proposed modifications would result in high visual impacts for road users travelling on limited sections of the Castlereagh Highway (see page 113) and for some rural residences in the Cullen Valley (see page 115). The proponent has committed to implementing visual impact treatments as described in Section 6.14.4 (see Section 7, Statement of Commitments). These mitigation and management measures include the implementation of bunding and tree screening. There would be a time lag before these measures would effectively reduce the identified high visual impacts.

It is recommended that the Draft EA be revised to provide evidence that this time lag is acceptable to the agricultural community, including rural residential landholders and nearby agricultural businesses.

## Recommended response to this issue:

It is recommended that the Statement of Commitments (Section 7) be revised for both modifications to require the proponent to consult with the agricultural community to ensure that the visual impact treatments described in Section 6.14.4 are implemented in a way that would effectively reduce the identified high visual impacts within an acceptable time frame.
