Dear Sir/Madam

I own the property at 25 Princes Highway, Foxground, Lot 11 D.P. 607155. I vehemently opposed the RTA, RMS or DMR or any other body taking any of my land for an expressway. I bought this land nearly 30 years ago and have put countless hours and a few million dollars into developing it into a tourist facility. It is due to open early 2013. I have future plans to develop the entire 75 acres with attractions which my grandchildren and their children will continue to operate. I will enclose a plan of what I already have and what attractions I hope to put in the future.

The RTA already owns Richard and Tracey's goat farm behind me and they have bought Gary and Di Schofield's property behind that so why not use the land that you already own and leave mine alone.

In 2005 after we beat the Council at the Land and Environment court, the Council made it mandatory for me to build the house where it is situated now.

I have been to Berry and seen the plan of what land the RTA proposes to take of my land. I don't see the need to take an extra 20 metres from the edge of the freeway for a corridor. I think 3-5 metres is sufficient or don't take any of my land and I will grant you access when and if needed.

Also because the property was a beef cattle farm before I purchased it there is hardly any good size trees which I intend to put up a rope coarse on. If you intend to resume that corner of my property I will be faced with nowhere to put my rope coarse unless I use expensive concrete piers.

I also object to granting access to extra homes to use my lane-way cut into my hill and put a tunnel on my land.
