Dear Sir,

For nearly 20 years my company, Delta Laboratories has operated a Pharmaceutical manufacturing plant in Somersby NSW. As you would know, the Pharmaceutical industry is closely governed by strict guidelines regarding the type of materials we use, how we dispose of them and indeed air quality. We have invested significantly to ensure that our HVAC systems are compliant, and that our staff have a safe environment in which to work.

Our business employs over 100 staff, most of whom are local Central Coast residents. Over the years we have fostered close relationships with our staff who are like extended family, as well as other local businesses in the area.

We are all strongly opposed to the DA by Kariong Sand and Soil (resubmitted as Davis Earthmoving and Quarrying Pty Ltd), and my staff are extremely concerned about the fine dust particles this may create. Delta Laboratories has recently purchased a second site, just off Gindurra Road. In addition to the extra filtration we anticipate needing to account for, the staff that are to move to this site are concerned about the proposed concrete-dust creating site. A facility such as this should not be located so close to such a populated area.

Attached is a petition signed by just some of my staff members who happened to be available this afternoon when I wrote this letter.

I implore you to consider the health and safety of our residents, businesses and working population when making your decision about this proposal.
