We view Cultural Heritage as apart of Mine Lease Rehabilitation from the Community Health Impact point of view; and this encompasses, Physical, Mental, Social, Sense of Place with recognition of our Ancestral (Aboriginal, Colonial, Convict & Emigrant) Heritage that is trampled upon and often destroyed especially by Open Cut Coal Mining in the Hunter Valley. In the SSHEG Wambo – United Mines Submission we foreshadow that the "Cockfighters Valley Precinct" will form part the "NSW Patricks Plains State Significant Area#" to encompass the 1820's Aboriginal, Colonial and Convict Significance as an adjunct of the Yengo and Wollomi National Parks, being an integral part of the UNESCO Greater Blue Mountains National Parks. A somewhat tacit focus on Ancestral Heritage in Singleton Shire Council continues today: however the stark difference between the Heritage Conservation initiatives of the adjoining Cessnock, Maitland, and Muswellbrook Councils is compared to the underdeveloped Singleton Council support as displayed on Council web sites. Ravensworth Homestead Estate is uniquely significant in its four Cultural Heritage entities; namely, Aboriginal, Colonial, Convict and Emigrants Heritage. It is these aspects that Glencore are attempting to circumvent their Obligations and Social Licence for Open Cut Mining in the Hunter Valley by a select and apparent secret Singleton Shire Committee. 




Figure 6 Aboriginal Archaeological Sites Registered on the AHIMS Database within and
