**Cumberland Council raises strong objection to the modifications as requested.**

Please find our detailed comments below for the modification requested:

Right Turn ban from Parramatta Road:

Council will not support removing condition (119) as right turns into the private road impacts on Parramatta Road traffic.

This request will also need to be assessed by the RMS also as Parramatta Road is a State road.

Access to all light vehicles via the internal access road off Rawson Street:

The intersection of Rawson Street, Highgate Street and the Private Road shall be analysed for queue lengths towards Parramatta Road.

General comment:

*Based on Council's LGA Wide Traffic Study in 2013, the intersection of Rawson Street, Parramatta Road and Duck Street is operating at levels of service D in the morning peak and F in the evening peak. The traffic has increased since then and it is expected to further increase after the introduction of tolls on M4.*
