RE: Biala Wind Farm - Aeronautical Impact Assessment

The Department of Defence (Defence) would like to thank Aviation Projects for providing Defence an opportunity to comment on the Biala wind farm. Defence understands that the applicant is seeking approval to construct and operate a wind farm facility with up to 31 wind turbines. The proposal is located approximately 8km east of Biala in the Upper Lachlan Local Government Area.

There is an ongoing requirement to obtain and maintain accurate information about tall structures. The risk posed by a tall structure to aircraft safety can be minimised if information on the tall structure is conveyed to pilots so that they can fly at a safe margin above the structure. The RAAF Aeronautical Information Service (RAAF AIS) in Melbourne is responsible for recording the location and height of tall structures. The information is held in a central database managed by RAAF AIS and relates to the erection, extension or dismantling of tall structures the top of which is:

- a. 30 metres or more above ground level within 30 kilometres of an aerodrome, or
- b. 45 metres or more above ground level elsewhere.

The proposed structure will meet the above definition of tall structure. Defence therefore requests that the Developer provide RAAF AIS with "as constructed" details. RAAF AIS has a web site with a Vertical Obstruction Report Form at www.raafais.gov.au/obstr\_form.htm which can be used to enter the location and height details of tall structures.

Defence requests that the Wind Farm should be lit in accordance with Civil Aviation Safety Regulation 139 and the Civil Aviation Safety Authority (CASA) Manual of Standards 139. If Light-Emitting Diode (LED) obstruction lighting is applied to the Wind Farm, the frequency range of the emitted LED light is requested to fall within the wavelength range of 655 to 930 nanometres. This will enable the lighting to be visible to persons using night vision devices.

Defence understands that Aviation Projects have forwarded this application to AirServices Australia for assessment.

Defence does not object to this project subject to clearance and Aviation Projects' adherence to conditions provided by AirServices Australia and CASA requirements.

To mitigate potential impacts to Defence activities, Defence requests to be consulted should there be any subsequent modification in wind turbine height or scale of development.
