Description of proposal

A new Southern Concourse at Redfern Station comprising:

- A six-metre-wide concourse between Little Eveleigh Street and Marian Street, including new lift and stair access from the concourse to Platforms 1 to 10;
- A new station entrance on Little Eveleigh Street, and an upgraded entrance on Marian Street, including station services and customer amenities; and
- Upgrades and improvement works to Little Eveleigh Street and Marian/Cornwallis/Rosehill Streets, including works to improve safety of pedestrians, cyclists and vehicles.
