Description of the development consent

Concept approval was granted for:

- A maximum building envelope, including street wall and setbacks for the over station development;
- A maximum building height of RL 171.6 metres;
- Podium-level car parking for a maximum of 34 parking spaces; and
- Conceptual land use for either one of a residential or a commercial scheme (not both).

#### Description of proposed modification

Proposed amendments to the Pitt Street South Over Station Development concept approval to:

- Permit the inclusion of 'retail premises' as an approved land use within the building podium; and
- Amend Condition A15 to allow for protrusions beyond the approved building envelope for Architectural embellishments, awning and balustrade structures.
