Detailed design, construction and operation of a new 45,000 seat stadium and associated public domain.

## Description of proposed modification

The modification request seeks approval for a Precinct Village and 1,500 space multi-level carpark adjacent to the new stadium, incorporating a single storey retail pavilion, four tennis courts, ancillary landscaping and the reconfiguration of stadium pedestrian and vehicular access.
