Instead of tax-payer's money spent on developing Darling Harbour which is already beautiful, the money could be best spent on developing the rundown areas leading to and from the Kingsford Smith Airport which are an eyesore to tourists as well as to the people of NSW.

Many International Airports around the world have well maintained, wide roads to welcome and impress tourists and travellers into their city but Sydney lacks that.

Mr Tim Parker (Project Director) wrote about quote' ensuring that Sydney has world-class convention, exhibition and entertainment facilities befitting of a global city will generate \$200 million each year in economic benefit for the taxpayers of NSW - a total of \$5 billion to the State over 25 years, when the entrance, the "door to the city"(roads & infrastructures) are not fixed first and in need of upgrading. Adding to the private high-rise at Darling Harbour with no open, eye-level space, separating the surrounding Chinatown, Power House museum, Paddy's Market and Chinese Friendship Garden, one can argue that the public land put aside for the people of NSW has shrunk and about one third is now used for private development.

The criticism raises questions over how Darling Harbour will cope with predicted crowd numbers following its highly-billed remake, which includes an expanded outdoor event space to hold 27,000 people and Australia's largest convention space for more than 12,000 people. ETC......

The Government has a duty of care when planning this big project of State Significant Development, taking ALL aspects into consideration especially Health & Safety

How it is going to impact on the neighbouring residents, the workers, the retailers that are already there, during the process of construction which will take many years.

In view of a terriorist attack or disaster, with more residents and visitors to Darling Harbour, how will the Emergency Disaster Plan work, with hospital fundings cut, hospital wards closed and staff not being replaced when they leave?

Today, in the city CBD. a fire from a restaurant kitchen sent thick smoke from one of the buildings, sending 1000s of city workers and people scrambling for safety in the streets. It took several fire engines to put the flames out and the city to lockdown, it was chaotic and that is only one kitchen fire!
