## **Description of proposal**

The SSD application involves the expansion of an existing landfill, including:

- progressive excavation, landfilling and rehabilitation of eleven new landfill sub-cells;
- increase in waste acceptance from up to 30,000 tonnes per annum (tpa) of putrescible and non-putrescible waste to up to 100,000 tpa;
- upgrade and operation of recycling drop off and resource recovery facilities; and
- construction of ancillary infrastructure including leachate ponds, landfill gas management system, stormwater basins and internal roads.

The application for State significant development (SSD), Environmental Impact Statement (EIS) and accompanying documents will be exhibited from **Tuesday 22 February 2022** until **Monday 21 March 2022** and are accessible electronically on the Department's website
