POTENTIAL POINTS OF SUPPORT FOR THE ROCKY HILL COAL PROJECT

JOBS

- Jobs are needed in Gloucester
- An opportunity to provide up to new 100 construction jobs and 150 operational jobs should not be lost
- A diversity of employment opportunities is needed in Gloucester- existing businesses are laying people off and other businesses are hurting
- I believe that the planned mine will provide an employment future for the youth of the area, in the area
- There are few job opportunities for young people/school leavers in Gloucester other than the family farm. The Rocky Hill mine will provide both direct and indirect opportunities for employment

ECONOMIC

- The opportunity for an injection of over \$18million annually into the local economy should not be lost and nor should the potential benefits arising from the \$7-8million provide to the community through GRL's community grants program
- Gloucester needs new developments if it is to survive. It will never become the food bowl for NSW because the land is generally poor, has acidic soils and is of low productivity. The absence of Class 1 and 2 land and the minimal class 3 land in the 100 or more square km of the proposed mine site demonstrates this
- Experience shows that with mining, property values increase, not decrease as claimed by some
- The local, NSW and Australian economies need the \$250million, \$1.3billion and \$3.6billion boost provided by the Project
- NSW needs to demonstrate that it is not only open for business but an attractive place for investment, with projects such as Rocky Hill that are scientifically, economically and socially sound being supported by government and not subject to disproportionate influence by vocal minorities with particular agenda.
- I believe that the planned mine will be a godsend to Gloucester's economy
- Based on Council's current differential rating scheme, the presence of the mine would result
 in an increase in rates income to Council of more than \$250000 annually or more than 5%
 and, at least partially, alleviate the need for the currently proposed massive rates increase

SOCIAL

- The Rocky Hill mine will provide education opportunities, trades and skills training and jobs
 which will encourage youth to stay in the local area and provide qualifications and
 experience which will be of benefit in a range of fields both during and after the mine ceases
 to operate
