I have reviewed the proposed Concept Plan modification 4 and SSD 6962 application and concluded that there are no environment, natural hazards or Aboriginal cultural heritage issues that require a formal OEH response given these matters were addressed at Concept Plan approval stage and the modification changes will not impact on the relevant commitments (i.e 6 and 14).

However, I am attaching some correspondence that was provided to both Mirvac and ecological consultant David Robinson on the retirement of biobanking credits. I also spoke with Necola Chisholm about this so would appreciate it if you could forward this email to her too. I suggested the wording for this commitment was rather vague especially with reference to the responsible party being future developers. I am just wondering who is responsible for ensuring it happens – I presume it's DPE but is there any reporting mechanism that we could incorporate into this process that would enable OEH to be informed when the commitment is met? Or perhaps we (OEH) need to develop an internal process so we can track the retirement of credits when they are a condition of consent.

- associated infrastructure works including a new signalised intersection at Wallgrove Road where
  it intersects the main site access road.

The modification request and the DA including the Environmental Impact Statement (EIS) will be on public exhibition from **Wednesday**, **5 August 2015** until **Monday**, **7 September 2015**.
