I object to the proposed Shenhua Watermark Coal Mine at Breeza NSW.

As ex- Mayor of Gunnedah Shire Council (1987-95) and chair of the Stakeholder Advisory Group of the Namoi Catchment Water Study I am appalled at the advancement of exploration and mining licences throughout NSW, at such a rapid rate without due diligence.

Prior to the state government election in 2011, we were promised that Prime Agricultural Land would be protected. The draft Strategic Regional Land Use Plan was put forward. The Foreword of the draft recognised the Liverpool Plains as one of the states' richest agricultural areas, but the plan did not meet the pre-election promises.

Minister Brad Hazzard visited Gunnedah and promised to address vital missing points put forward by the meeting.

What happened? The SRLUP was gutted. Buffer zones were eliminated and the protection of water resources and prime agricultural land ignored.

Shenhua Watermark mine is no ordinary mine, it is a mega mine. Local and neighbouring farmers in the area will not be able to continue their farming operations without this planned mine effecting and contaminating water resources, crops and stock, plus dust, noise, and the effects on their general health. They will ultimately be forced to leave. The social environment of the area will be decimated.

Shenhua Watermark, however, will be allowed to char ge the total environment. They will be redirecting water (Watermark Gully), clearing large tracts of land, remove Aboriginal sacred sites, remove the koala, change the climate system and generally contaminate the area.

What appears could be a short term financial fix for the State Government, will ultimately be a long term loss if water resources and a griculture are destroyed.

Remembering the now disgraced Minister Ian MacDor ald issued this exploration licence, I have always questioned \$300ml being paid instead of the \$20 ml in the Expression of Interest document.
