Western Sydney Stadium Concept Proposal and <u>Stage 1 Demolition</u>. Application No. SSD 7534

Statement in Support or Objection: Objection to the proposed demolition of the current complex. It's capacity already seats in the versinity of 26,000 spectators. The grandstands have no structural floors and are Arcitedtually cutting edge concrete design.

Reason as to why: Parramatta Stadium is a state of the art, modern, picturesque, facility located 25km west of the Sydney CBD. It was built in 1986 a gift from the then Labour Government to it's core heartland voters the working class battlers who longed for something better than the then derelict Cumberland Oval.

It was renamed Pirtek Stadium in 2007 or there about's sometime after the former Manager of the failed Parramatta Football Club failed to convince the Parramatta Park Trust to sell the entire facility to the Leagues club. This resulted in most home games being moved to Stadium Australia. After being deposed by a boardroom coup this Manager then gained a seat on the Park Trust and subsequently commercialised the non for profit organisation as a matter of self interest and ego. This seat on the board was consequently filled by a compromised un imparsial family member to deflect aspersion or investigation of this person who no doubt has motivations to retake control of the leagues club as the opportunity has now arisen.

The light towers are 4 piece steel tubular sections with a platform atop each at the light head. All 4 are in as new condition and are available for relocation to Liechardt Oval wish was left out of of the Stadium upgrade planning as the Tigers club is now controlled by the Western Suburbs club who would prefer to play out of Orana Park.

This is demonstrated by the current coach ability to stay in the job whilst sacking the NSW representative rake the same as occurred as at the Bears in the 90's. Coach will lose his job the result. Lobbied by the Billionaire soccer club owner/s the Government finally caved into this

taxpayers pressure and approved the plan for a Purpose built soccer ground facility with a mosque to be built on the memorial swimming pool site.
