1962 Dec Father, Lino passed away.

1964 Apr Gabriel Menolotto married Violet Anderson. They lived and worked with the family and also raised their family of six boys and three girls

1967 Gabriel, Gianino and Mario Menolotto purchased 5.5 acres, with house, Lot 30 The Horsley Drive Horsley Park.

1988 Lot 26A Cowpasture Rd Horsley Park Sold to State Planning authority

2005 Giannino & Anna Menolotto sold Lot 30 Horsley Dr. Horsley Pk to SPA

Gabriel, Violet and Mario Menolotto are the current owners of 200-212 Cowpasture Road Wetherill Park. The Menolottos have a long history with, and are well know in the area as market gardeners, local general carriers and Suppliers of Petroleum products.




Figure 3.2: Preliminary Concept Masterplan Layout (Source: Hansen Yuncken)
