Manning Colliery – Section 75W Modification to MP06_0311 (MOD 2)
Chain Valley Colliery - Section 96 Modification to SSD-5465 (MOD 1)

Thank you for the opportunity to provide comment on the proposed modifications to the Manning Colliery and Chain Valley Colliery as referenced above. Further to Council's submission dated 10 June 2014, the following comments are provided specifically in relation to Council's sewer infrastructure:

- There is a Council sewer rising main located within the project area for the proposed underground connection of Chain Valley Colliery and Manning Colliery as shown as a dashed line on the attached aerial photograph. The analysis contained in the subsidence assessment concludes that there will be no adverse impact on existing infrastructure due to the minor nature of subsidence, although this particular rising main has not been specifically addressed in the report. To ensure that Council's infrastructure is protected from any subsidence associated with the proposal, it is requested that a monitoring and management plan be included for the MP01 sewer rising main as part of the approval conditions for the Manning Colliery.
