I'd like to make a comment on the North West Rail Link Environmental Assessment 2 just released.

Overall I support the proposal, and look forward to seeing work start on the NWRL.

However, I have a concern that I am hoping can be addressed at this planning stage in relation to Cherrybrook Station.

I am a resident of Cherrybrook, not too far from Robert Road. The plan indicates no parking will be allowed on Robert Road from Castle Hill Road to John Street. This makes sense, to allow a free flow of traffic through to the station. However what this will do is push all-day parkers onto the streets just off or very close to Robert Road such as mine. This is very undesirable as you would understand.

To counter this, I note there are only 400 car parks being built at Cherrybrook, and there are 3 tracts of large space that are not yet earmarked for any specific purpose on the plan. Given the number of residents from Cherrybrook, West Pennant Hills and Dural that will access Cherrybrook station, I am sure you will recognise that 400 car spots is simply not enough. They will be full up in about 15 minutes if you see the number of cars on Castle Hill Road each morning.

It would be much better for all if this issue could be addressed now, and increased car parks made available. This could be done through the use of those 3 spare open spaces as indicated on the plan, and also by increasing the number of levels/storeys of the car parks. One of the car parks is for only 60 people, the other for 340 with 2-3 levels. If extra storeys were added there, this would significantly help solve the problem. I would target 600 car parks.. thereby removing 200 cars from parking on side streets around Cherrybrook station.
