

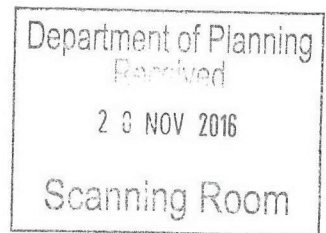

PREVENTS GROWTH AND EXPANSION


