## Part 3A/State Significant Development Application - Samuel Gilbert Public School - Corner Ridgecrop Drive and Gilbert Road Castle Hill

I refer to your correspondence dated 20 November 2018 seeking key issue and assessment requirements regarding bush fire protection for the above Part 3A/State Significant Development Application in accordance with section 75F (4) of the 'Environmental Planning and Assessment Act 1979'.

The New South Wales Rural Fire Service (NSW RFS) has considered the information submitted and provides the following advice:

- 1. At the commencement of building works and in perpetuity, the enclosed area of the school grounds bounded by the existing fence, (excluding the two small areas of EEC Turpentine-Ironbark Forest labelled as significant Vegetation zone) shall be managed as an inner protection area (IPA) as outlined within Appendices 2 & 5 of 'Planning for Bush Fire Protection 2006' and the NSW Rural Fire Service's document 'Standards for asset protection zones'.
- 2. The provision of water, electricity and gas supplies shall comply with sections 4.1.3 and 4.2.7 of 'Planning for Bush Fire Protection 2006'.
- 3. A Bush Fire Emergency Management and Evacuation Plan shall be prepared for the school or the existing plan amended to include the new buildings. The Plan shall be consistent with 'Development Planning A Guide to Developing a Bush Fire Emergency Management and Evacuation Plan December 2014'.

- 4. Proposed Building N shall comply with Sections 3 and 5 (BAL 12.5) Australian Standard AS3959-2009 'Construction of buildings in bush fire-prone areas' or NASH Standard (1.7.14 updated) 'National Standard Steel Framed Construction in Bushfire Areas – 2014' as appropriate and section A3.7 Addendum Appendix 3 of 'Planning for Bush Fire Protection 2006'.
- 5. New works proposed to Building A shall comply with Sections 3 and 5 (BAL 12.5) Australian Standard AS3959-2009 'Construction of buildings in bush fire-prone areas' or NASH Standard (1.7.14 updated) 'National Standard Steel Framed Construction in Bushfire Areas 2014' as appropriate and section A3.7 Addendum Appendix 3 of 'Planning for Bush Fire Protection 2006'.
- 6. Landscaping within the site shall comply with the principles of Appendix 5 of 'Planning for Bush Fire Protection 2006'.
