M4/WestConnex Motorway - Environmental Impact Statement (EIS) - Stage 1

Penrith City Council welcomes the State Government's commitment to the delivery of the WestConnex project, as identified in the NSW Long Term Transport Master Plan.

We acknowledge and welcome the benefits of the M4 Widening as the first stage of the WestConnex project, in providing greater certainty to travel times on the M4 Motorway between Parramatta and Homebush. The increased lane capacity provided by the project will result in smoother traffic flow and a reduction in delays. It will also provide a better link to Sydney's west with its international gateways and key places of business and facilitate significant reduction in travel times.

Our Council is however, concerned that the provision of tolls on this road system will create a significant cost burden on Western Sydney commuters, and therefore potentially undermine its benefits.

Information relating to the NSW Long Term Transport Master Plan and WestConnex project were considered at Council meetings in March and April 2013, respectively. In response to these reports, Council resolved to express its strong view that it does not support any toll on the M4/WestConnex.

In response to the exhibited EIS, Penrith City Council wishes to reaffirm that it supports the M4/WestConnex project, but that it does not support the introduction of tolls as it will significantly burden Western Sydney motorists.
