# Myuna Colliery – Modification 2

**Location** 25 kilometres south-west of Newcastle

Applicant Centennial Myuna Pty Limited

## Description of the development consent

- Underground mining, extracting up to 3 million tonnes per annum (Mtpa) of run-of-mine (ROM) coal;
- Transport of coal from site via overland conveyor to Eraring Power Station; and
- · Associated infrastructure to support mining and coal production activities until 2032.

### Description of proposed modification

The modification seeks approval for:

- Transport of up to 1.0 Mtpa of ROM coal by road from Myuna Colliery to Cooranbong Entry Site (CES);
- Receipt of up to 0.2 Mtpa of Mandalong ROM coal by road from the CES; and
- Construction and use of a weighbridge.
