Hi Luisa and Teresa,

I refer to your request for an Airservices assessment of the Concord Repatriation General Hospital Redevelopment at 1H Hospital Road, Concord West.

### **Airspace Procedures**

With respect to procedures designed by Airservices in accordance with ICAO PANS-OPS and Document 9905, at a maximum height of 43.5m (143ft) AHD, the property development will not affect any sector or circling altitude, nor any instrument approach or departure procedure at Bankstown, Camden, Richmond or Sydney Airport and Westmead Hospital HLS.

The property development will not affect the Sydney RTCC.

Note that procedures not designed by Airservices at Bankstown, Camden, Richmond or Sydney Airport or Westmead Hospital HLS were not considered in this assessment.

### **Communications/Navigation/Surveillance (CNS) Facilities**

This property development, to a maximum height of 43.5m (143ft) AHD, will not adversely impact the performance of Precision/Non-Precision Navigational Aids, HF/VHF Comms, A-SMGCS, Radar, PRM, ADS-B, WAM or Satellite/Links.
