Hi Iona

Thank you for taking my call today to discuss the proposed development at 2 Percy Street, Auburn SSD 8926.

Sydney Trains and TfNSW collaborated to provide a response to the SEARs when they were issued by Department of Planning & Environment (DP&E), which I have attached for ease of reference. A request was made for an extension on the response time, granted by DP&E to December 19, and the attached was emailed to DP&E on December 18. For Sydney Trains, the request was that if the development was within 25m of the rail corridor (owned boundary) with 2m of more ground penetration then specific documentation was required for Sydney Trains to review. Additionally, it was requested that Sydney Trains was included as part of the consultation process.

Sydney Trains notes that when the SEARs was issued, the request for consultation with Sydney Trains was not included. Further to this, the documentation submitted by the applicant does not reflect the information requested as per the collaborated letter response from TfNSW. Sydney Trains is unable to continue their review or provide further comment until the documentation requested has been supplied and the applicant has discussed their proposal with Sydney Trains. It is recommended that the Applicant consult with Sydney Trains prior to providing additional documentation to ensure the detail required for engineering and structural review is incorporated in the documentation; the applicant is welcome to contact me to discuss Sydney Trains concerns via email to DA_sydneytrains@transport.nsw.gov.au
