- b) The formal process will commence shortly, with the target date for opening is Jan 2021 correct
- c) DET is comfortable / prefers to see an R3 re-zoning on the land to the south of the future school **DoE has no objection to the R3 zoning**
- d) DET is comfortable with a Council road on the southern boundary of the future school site correct
- e) DET would also like to seek an R3 rezoning over the future school site to better accommodate their future needs / alternative uses **preferred but not a key driver at this stage and should not hold up the site acquisition.**
- f) Catalina and Toplace are agreeable to a joint rezoning application over the whole area to R3, including the future school site on both Toplace's and Catalina's land **noted**
- g) All parties will work together to achieve the rezoning DE will provide support for this in line with e) and f)

- i) Confirmation in writing from DOPI that the Department will accept an R3 rezoning proposal over the whole area, including the area to be acquired for the school **you will need to get this from Planning**

j) DE would intend to commence the process of acquiring the site with the valuation to be based on current zoning. DE's capacity to acquire the site and provide a school will depend upon site affordability and funding approvals.
