Attachment A – Key Issues Alesco Senior College, Charlestown (SSD-10478)

1. Earthworks

- The Environmental Impact Statement (EIS) states that earthworks are necessary to create a level building platform, associated car park and play areas and to meet accessibility requirements. Please detail the extent of earthworks proposed to be carried out on the site and provide an Earthworks Plan that outlines the extent of cut and fill volumes.
- Provide final proposed levels in relation to current levels on the site and adjoining sites, including long sections through the site.
- Confirm whether the disturbed soils would be re-used on the site (i.e. for landscaping) or whether soils would be required to be disposed of off-site.

2. Construction noise

• The Noise Impact Assessment (NIA) states that no earthworks will take place on the site and that the construction noise levels are not expected to exceed 75dB(A), which represents the highly affected noise level for residential receivers during the day-time period (as set out in the Interim Construction Noise Guideline (EPA, 2009)). As the EIS confirms that earthworks are required, the conclusions and recommendations provided in the NIA should be reconsidered and the report revised, where necessary, to account for the potential noise impacts of the onsite earthwork activities.

3. Outdoor recreation

The EIS states that the school would not provide for on-site physical and outdoor recreation
and will utilise Lake Macquarie City Council (Council) owned playing fields and public parks.
Further information is requested in relation to the school's outdoor recreation arrangements,
including the specific locations (i.e. Council parks and playing fields) that would be utilised by
the school, the frequency of use and the means of transporting students and staff to and from
these off-site locations.

4. Transport

- Address the draft Charlestown Transport Management Plan, prepared by Council, including how the proposed school may benefit from the strategies and actions proposed under the draft plan.
- Update and prepare a comprehensive Green Travel Plan in accordance with the recommendations provided in the submission from Transport for NSW.

5. Signage

The EIS states that the proposal does not seek detailed planning approval for any signage. It is
therefore requested that the "New Signage" notations and proposed signage zones shown on
the architectural plans submitted for approval be removed (specifically for DA-2001 and DA3001) and these plans re-issued as part of the Response to Submissions.
