I have been living at the above address with my partner for many years and have seen many changes that have seen the student numbers increase. Going with these changes I have seen no infrastructure improvements to cater for the increased traffic that comes with the increase in student numbers.

I support the development if it is to benefit the well being of the students and to improve their learning potential.

I oppose the development if it is to solely increase the student number of this school which I feel as though is already at over capacity. ( I mark with asterisk on the attached sheet to which I object )

Reasons for objection:

- [1] Very often there are as many as 4 buses outside our building with engines running for up to 1 hour at school finishing time causing pollution.
- [2] Traffic congestion at times from Redmyre Road into Raw Square.
- [3] Traffic congestion at times from Margaret Street into The Boulevarde.
- [4] Driveways blocked due to traffic congestion.
- [5] Sometimes the Police are on duty to assist traffic flow.
- [6] Increased extra activities and noise from 7am onwards.

The above reasons are causing discomfort to local residents and I feel another 130 students added to this school can only cause more discomfort.

I would like to thank you for giving me the opportunity to express my opinion on the proposed development and hopefully my concerns are considered.

## **Description of the development consent**

Alterations and additions to Meriden School consisting of:

- Demolition of the staff common room on the Senior School, the existing business office on the Prep School and the house and garage at 4 Vernon Street on the Junior School currently used as the uniform shop;
- Site remediation and excavation on the Junior School and Prep School;
- Construction of a new three storey Music and Drama Centre with two basement levels at the Senior School;
- Construction of a new two storey Administration and Student Centre building at the Prep School;
- Construction of a new outdoor landscaped space with outdoor furniture, pergola and noise barrier at the Junior School;
- A change of use at 4 Vernon Street from a residential dwelling to an educational establishment; and
- Ancillary public domain works, landscaping, drainage works and service connections.

Modification to increase senior school student numbers by 130, design alterations and amendments to Ecologically Sustainable Development (ESD) building certification conditions.
