I wish to **object** to the proposal of Moorebank Recyclers P/L - Application No.: 05_0157

Currently, we have Benedict's Recycler on Newbridge Road, Moorebank in the area of the new proposed Moorebank Recyclers P/L site.

The Benedict's site has mountains, approx. 15metres plus in height, of recycle material like sand, dirt, crushed concrete etc. When the wind blows the dust from the Benedict's site blows over our cloths on the washing line, our house and car. This dust is not good for our family member's health, especially our young children.

As Benedict's have set a precedent, we do not need Moorebank Recyclers P/L building more mountains of sand, dirt and dust to blow over our homes and affecting our family health.

With building and construction waste being delivered to Moorebank Recyclers, what controls will there be to stop any **ASBESTOS fibrous material and other dangerous materials** being delivered to the site.

I wish to **object** to the proposal of allowing trucks and semi trailers access to the proposed Moorebank Recyclers P/L facility via Brickmakers Drive, Moorebank.

We currently have a lot of heavy vehicles dumping recycle material at Benedict's recycle site and with current complaints with regards to heavy vehicle in the Moorebank area, we cannot allow this new company to set up business to bring in more heavy vehicles into a housing development family environment with young children. Brickmakers Drive, is a by-pass road, single lane in both directions and not suitable for trucks and semi trailers accessing and exiting the proposed Moorebank Recyclers P/L facility.

Brickmakers Drive, Moorebank was an item on Current Affairs TV show recently, which show how large trucks and semi trailers were speeding, crossing over the road centre line and running over roundabouts, instead of going around them. **The WARNING signs of a big accident involving large trucks and semi trailers** on Brickmakers Drive, Moorebank, have been supported by safety experts, as shown on the TV show.

We do not need a second building and construction waste Recycle company in the Moorebank area. We currently have enough problems with Benedict's Recycler on Newbridge Road, Moorebank.
