## APPENDIX J: LAND TENURE



Table J1 contains a formal description of the land which has been identified as being within the project boundary along with a description of the interest to be acquired by Hunter and Central Rivers Catchment Management Authority for the purpose of the project.

Please note that:

- No formal survey has been carried out to determine the identity of the land which falls within the project boundary, and thus the list below may not be fully inclusive of every parcel of land affected by the project, however, considerable effort has been made to ensure that the list accords with Newcastle City Council records of affected properties.
- The list does not contain land covered by the Hexham Swamp Nature Reserve (Lot 1 DP 90465 and Lot 129 DP 725084), as these parcels of land are exempt for requiring development consent.
- The floodgates will not be opened until such time as Hunter and Central Rivers Catchment Management Authority has acquired either:
  - ➤ a registered easement in gross; or
  - ➤ the freehold; or
  - > the written consent of the registered proprietor to carry out the project;

over all the land which falls within the project boundary.

- Not all of the land included in Table J1 is entirely within the project boundary. Where land set out in Table J1 does not fall entirely within the project boundary Hunter and Central Rivers Catchment Management Authority is only acquiring an interest over that part of the land which falls within the project boundary (which is defined on the maps at the end of this appendix).
