NCIG Coal Export Terminal Proposed Rail Flyover – (MP 06_0009) Modification Request No. 2

I refer to your separate letters to NSW Department of Primary Industries and the NSW Office of Water, an agency within the Department of Primary Industries, requesting comment on modifications to NCIG Coal Export Terminal (MP 06_0009) Proposed Rail Flyover.

Fisheries NSW has considered the proposal in relation to its responsibilities under the *Fisheries Management Act 1994* in relation to the sustainable management of commercial and recreational fishing in NSW, the protection of aquatic habitat generally, and the protection of threatened species. Reference in this regard is also made to the associated *Policy and Guidelines for Aquatic Habitat Management and Fish Conservation (1999)*. Fisheries NSW advises that there are no fisheries issues in relation to these works as there is no impact on fish habitats.

The NSW Office of Water provides the following comment and advice as to conditions on any approval of the proposal:

Reference is made in the EA to potential dewatering from excavations or to manage groundwater issues on the site. It should be noted that groundwater on the site is regulated under the *Water Act 1912* (WA 1912). All existing and proposed works including monitoring bores, excavation and dewatering works with the potential to intercept or extract groundwater require a licence under Part 5 of the WA 1912.

The proponent must obtain relevant licences to the satisfaction of the NSW Office of Water for all activities which intercept or extract groundwater prior to commencement of these activities.
