RE: Project Approval 06_0014 Mangoola Open Cut – Updated Conservation Management Strategy (CMS)

As required under Schedule 3, Condition 43 of Project Approval 06_0014, please find enclosed a revision of Mangoola Coals Conservation Management Strategy (CMS) for your approval. The CMS is to be prepared in consultation with the relevant landowners and OEH (formally BCD, and now Department of Premier and Cabinet, Heritage NSW).

There is only one relevant landowner that requires consultation for the CMS. Consultation was as follows:

- An email containing the CMS and a cover letter outlining the updates to the CMS was sent via email on 3 September 2020 requesting comments back by 17 September 2020. A voice message was left as well. No comments were received by 17 September 2020.
- A follow up phone call was made on 17 September 2020. A voice message was left. An email was also sent requesting the landowner make contact by 18 September 2020 if they wish to comment.
- An email was received from the landowner on 18 September requesting 'a few days' to look over the CMS. Mangoola requested the landowner provide comment by 22 September 2020.
- Mangoola contacted landowner on 22 September 2020 however the landowner had not yet had a chance to review the CMS. Mangoola requested comments by 24 September 2020.
- A phone call was made to the landowner on 24 September requesting a call back with comments by COB.
- No comments were received.

This CMS was then submitted through to the Department of Premier and Cabinet, Heritage NSW on 28 September 2020 for consultation and comment. Reference document DOC20/797207 was received from Department of Premier and Cabinet, Heritage NSW on 12 October 2020 noting *"After review of the above report it is considered that it is an appropriately detailed document to ensure the ongoing management of the locally significant historic and natural heritage detailed within it, for the lifetime of the mine"*. This consultation has been added as an attachment within the portal.

There have been two revisions to the CMS since the last approval. Version 7 was submitted through the portal for consultation however was withdrawn upon advice from the Biodiversity Conservation Division (BCD) (now known as Department of Premier and Cabinet, Heritage NSW). **Table 1** below outlines the changes made to the document.
