1 Background

There are a number of modifications that are proposed to be incorporated into the project that are outlined in Table 1 below.

The majority of these modifications are minor and, for the purposes of Section 75W(2), all would remain consistent with the Minister's consent to the Concept Plan and Major Project as (jointly) granted on 25th January 2007. However, for the sake of completeness and to apply a contextual relationship to the modifications – as well as to avoid confusion - these minor modifications have been included in this request alongside those having more significance (refer to Section 2 below).

1.1 Section 75W

The Environmental Planning and Assessment Act states that:

75W Modification of Minister's approval

(1) In this section:

"Minister's approval" means an approval to carry out a project under this Part, and includes an approval of a concept plan.

"modification of approval" means changing the terms of a Minister's approval, including:

- a) revoking or varying a condition of the approval or imposing an additional condition of the approval, and
- b) changing the terms of any determination made by the Minister under Division 3 in connection with the approval.
- (2) The proponent may request the Minister to modify the Minister's approval for a project. The Minister's approval for a modification is not required if the project as modified will be consistent with the existing approval under this Part.
- (3) The request for the Minister's approval is to be lodged with the Director-General. The Director-General may notify the proponent of environmental assessment requirements with respect to the proposed modification that the proponent must comply with before the matter will be considered by the Minister.
- (4) The Minister may modify the approval (with or without conditions) or disapprove of the modification.
- (5) The proponent of a project to which section 75K applies who is dissatisfied with the determination of a request under this section with respect to the project (or with the failure of the Minister to determine the request within 40 days after it is made) may, within the time prescribed by the regulations, appeal to the Court. The Court may determine any such appeal.
- (6) Subsection (5) does not apply to a request to modify:
 - a) an approval granted by or as directed by the Court on appeal, or
 - b) a determination made by the Minister under Division 3 in connection with the approval of a concept plan.
- (7) This section does not limit the circumstances in which the Minister may modify a determination made by the Minister under Division 3 in connection with the approval of a concept plan.

The proponent requests the Minister to approve of the modifications as are generally indicated in the Schedule titled "Section 75W notes" on the plans accompanying this request as provided in Table 2 below. The consequential amendments to the consent are therefore limited to the amendment to Condition A2 of Schedule 2 [which list the relevant

approved plans for the Project Major Project] so as to modify this condition to incorporate and refer to those architectural plans which incorporate the modifications specified in Table 2.

1.2 Consistency with the Concept Plan

The proposed modifications are consistent with the Concept Plan Approval (as modified) granted by the Minister.

1.3 Modifications sought to Consent 06_0149

The descriptions of the modifications sought are referenced in Table 1 (below) and are also listed in the Schedule on the plans accompanying this request. The modifications are identified on the plans by the appropriate alphabetical letter within a triangle symbol, referenced to the Schedule. Note that some of the modifications are classed by type (i.e. there may be more than one such change throughout). All modifications have been identified by "cloud" symbols on the drawings.

Table 1 is structured to identify and describe the modifications sought and to explain and justify the modifications. The final column of the table then considers the significance of each in the context of the original consent and the overall project. Where it is considered that a more specific or detailed assessment is required to further consider a modification, this is provided in the following Section 2 and is referenced in the conclusion section of Table 1.

This assessment is subject to any directions that may be given by the Director General under the provisions of S75W(3) for further environmental assessment (if required).

2 Assessment of the Proposed Modifications

Initial assessment has been provided at Table 1 above. This assessment is subject to any directions that may be given by the Director General in accordance with the provisions of S75W(3) of the Act. The following matters, while still representing overall contextually minor modifications, are provided with further assessment to that as provided in Table 1 above:

- Plant room extensions at Level 12
- Alterations to materials proposed (referenced in a sample board and materials legend on the architectural plans)
- The proposed roof garden or deck (Level 5) as related to consequential modifications required – noting that the use as a roof garden will be subject to a separate approval from the Redfern Waterloo Authority (RWA) as required by Condition 3 of Schedule 2 of the Concept Plan and Condition 6 of Schedule 2 of the Major Project Approval.

This assessment is provided below.

2.1 Plant room extensions

A greater volume of plant room than had been originally planned for has been made necessary as a result of a full mechanical design development, including necessary segregation of mechanical elements. Rather than reconfiguring the whole of the Level 12 plant room appearance, discrete locations have been found for the increased areas together with minor enlargements that, together, retain the overall planned silhouette of the building when viewed from the principal vantage points. These extended plant room areas generally remain beneath the canopy that comprises the plant room roof, retaining its overall original architectural resolution.

2.2 Alterations to materials

Several changes are made to the external finishes to those specified in the sample board as previously submitted. It is proposed that a revised materials sample board will be submitted for approval. A colour matched photograph of the sample board will also be submitted for the Department's approval and record purposes.

2.3 Proposed roof garden

The Landscaped Accessible Roof is subject to condition 3 of the Minister's consent to the Concept Plan, which states:

'3. Landscaped Accessible Roof

The "landscaped open roof" area (identified on Plan PA-007 'Floor Plan – Level 5' Revision F dated 27.11.2006) does not have clearly delineated edges or access points and due to lack of resolution of these details, is deleted. Any use of the roof area as an outdoor terrace, shall be the subject of a future application with the Redfern Waterloo Authority'.

The Project Approval also repeats this condition as condition A1(6) of Schedule 2. There is no need to vary either of the conditions as it is intended to seek approval for use of the roof deck from the RWA.

There are a number of consequential modifications to the building that will occur as a result of the use of the Level 5 roof area for outdoor recreation. These are identified in Table 1 (items P and Q). These modifications will be minor in context. The use of the roof is not sought in this modification as it is already subject to Condition A1(6) of Schedule 2. However, the physical modifications included in Table 1 are partly related to the use of the roof garden and it would be inappropriate to not include them for clarifying their context in this modification proposal.

3 Conclusion

The modifications sought are generally consistent with the original Concept Plan. There is no necessity to alter the Concept Plan approval. It is proposed that the modifications be effected through modification of the Major Project Approval, in particular through the modification of Condition A2 of Schedule 2 to reflect the amended architectural plans.

The most significant modification is the additional area/volume required for the plant room at Level 12. In this respect, the overall architectural integrity of the original design is not altered as a result and no significant impact, such as increased overshadowing to the nearby child care facility, will occur. There is also no significant bulk impact generated by the additional plant room space.

The submission of the materials sample board will enable the Department to consider these revised details when the specific samples are available. In the meantime the architectural plans describe all materials in the Legend on each drawing.

The consequential modifications to the building to incorporate a roof deck at level 5 are included in the submission to avoid the need for subsequent additional modifications. This will enable a better coordination of the process of meeting the requirements of Condition A1(6) of the Minister's consent relating to the necessity for a separate application for use of the roof deck to be lodged with the Redfern Waterloo Authority.

These modifications, together with those other minor modifications are therefore considered to be acceptable. It is considered that no additional environmental assessment is required. The proposed use of the roof deck will be subject to a separate application to the Redfern Waterloo Authority.

4 Recommendation

It is recommended that

- (1) the Director General determine, in accordance with Section 75W(3), that no additional environmental assessment is required in this case, and
- (2) in accordance with the provisions of Section 75W(4) the Minister modify the consent to incorporate the amended plans identified in Table 2 (above) and to modify Condition A2 of Schedule 2 accordingly.
