Project approval for the construction of a Studio and Office Complex (MP 06\_0149) granted by the Minister for Planning on 25 January 2007, comprising:

- Twelve (12) storeys including office space and plant room.
- Four (4) large studios and associated warehousing
- 41,800m<sup>2</sup> of gross floor space.
- Two levels of semi-basement car parking (697 spaces), one which is for use by the
  occupants of the building (347 spaces) and the remaining level is for use by the landowner
  including visitor/public spaces (350 spaces).
- A landscaped open plaza at the south-eastern end of the building adjacent to a café, retail shops and entry foyers as well as various storage and utility rooms all at ground floor level.
- A landscaped park at the western end of Central Avenue, to the south of the building.
- General office area in levels 1 to 10 of the building.
