### SCHEDULE 2

1. In the definitions list:
  - (a) Delete the definitions for DECCW, Director-General, I&I NSW and RTA.
  - (b) Insert the following acronyms and abbreviations in alphabetical order:

Department	Department of Planning & Environment
DRE	Division of Resources and Energy within the Department of Trade and Investment, Regional Infrastructure and Services
EPA	Environment Protection Authority
Minister	Minister for Planning, or delegate
OEH	Office of Environment and Heritage
RMS	Roads and Maritime Services
Secretary	Secretary of the Department of Planning & Environment, or nominee
2. Delete all references to "DECCW" and replace with:
  - (a) "OEH" in conditions 16, 17 and 20 of Schedule 3; and
  - (b) "EPA" in all other cases.
3. Delete all references to "Director-General" and replace with "Secretary".
4. Replace all references to "I&I NSW" and replace with "DRE".
5. Delete all references to "RTA" and replace with "RMS".
6. In condition 2 of Schedule 2, insert the following after condition 2(e):

(f) modification application 06\_0168 Mod 4 and accompanying Environmental Assessment titled *Murray Darling Basin Operations Modification Environmental Assessment November 2013*, dated November 2013.
7. Replace condition 8 of Schedule 2 with the following:

#### ***Updating and Staging Strategies, Plans or Programs***

*With the approval of the Secretary, the Proponent may submit any strategies, plans or programs required by this approval on a progressive basis.*

*To ensure the strategies, plans or programs under the conditions of this approval are updated on a regular basis, the Proponent may at any time submit revised strategies, plans or programs to the Secretary for approval.*

*With the agreement of the Secretary, the Proponent may prepare any revised strategy, plan or program without consultation with all parties under the applicable condition of approval.*

**Note:**

- While any strategy, plan or program may be submitted on a progressive basis, the Proponent must ensure that the existing operations on site are covered by suitable strategies, plans or programs at all times.
- If the submission of any strategy, plan or program is to be staged, then the relevant strategy, plan or program must clearly describe the specific stage to which the strategy, plan or program applies, the relationship of this stage to any future stages, and the trigger for updating the strategy, plan or program.
