 - 75 industrial lots that vary in area from 0.28 hectares to 2.46 hectares, for employment generating uses including offices that are associated with and on the same land as industry, warehouses, research and development;
 - o an area of land for the purposes of a business park and service retail use,
- Minor boundary adjustments between the SEL and adjacent land areas quarry batter walls, stormwater /
- sedimentation control basin, groundwater treatment plant and stormwater detention basins in community lot
 Dedication, to the relevant authorities, of roads and transit way corridors
