1. Insert the following definition into the definitions table

- 2. Replace Condition 2 in Schedule 2 with the following:
  - 2 The Proponent shall carry out the project generally in accordance with the:

    - (b) site plans (see Appendix A);
    - (c) Submissions Report;
    - (d) Remedial Action Plan (RAP);
    - (e) Statement of Commitments (see Appendix B);
    - (f) Exemption Application and EPA Exemption Order (see Appendix C);
    - (g) Technology Assessment;
    - (h) Modification application (06\_0028 Mod 2) with supporting documentation titled Supporting Documentation for a Request to Modify a Major Project Car Park Waste Encapsulation Remediation, Treatment of contaminated soils and concrete at the Directly-heated Thermal Desorption Plant other than those in the CPWE, prepared by Orica;
    - Modification application (06\_0028 Mod 3) with supporting documentation titled Orica Car Park Waste Encapsulation Remediation (CPWE) Storage of treated materials on Southlands, prepared by Orica and dated 15 September 2011;
    - (j) conditions of this approval.
- 3. Replace Condition 7 of Schedule 2 with the following:
  - 7 Nothing in this approval permits the disposal of surplus validated soil from the project outside land owned by Orica described in Schedule 1, or outside land owned by Orica within the Botany Industrial Park except for storage at area known as Southlands – Lot 1 on DP 85542 Lot 11 on DP 109505, Lot 1 on DP 1078077 and Lot 1 on DP 254392 and disposal at a licensed landfilling facility that can lawfully receive the surplus validated soil
- 4. Insert Condition 7A after Condition 7 of Schedule 2

Treated, validated soil may be temporarily stored at the Southlands site for a period of up to 24 months from the date of approval of Mod 3, subject to the storage location being approved by the site auditor.
