General Requirements	The Environmental Assessment of the proposed modification must include: a nexecutive summary; a detailed description of the following within the site and any associated areas: historical operations/activities; and existing and approved operations/facilities, including any statutory approvals that apply to these operations and facilities. a detailed description of the project, including the: need for the modification; proposed modifications or upgrades to activities or infrastructure; alternatives considered; various components and stages of the proposal; likely interactions between existing and proposed operations; and plans of any proposed building works; a risk assessment of the potential environmental impacts of the project, identifying the key issues for further assessment; a detailed assessment of the key issues specified below, and any other significant issues identified in the risk assessment (see above), which includes: a description of the existing environment, using sufficient baseline data; an assessment of the potential impacts of the project, including any cumulative impacts, taking into consideration any relevant guidelines, policies, plans and statutory provisions (see below); a description of the measures that would be implemented to avoid, minimise, mitigate, rehabilitate/remediate, monitor and/or offset the potential impacts of the project, including detailed contingency plans for managing any significant risks to the environment; a statement of commitments, outlining all the proposed environmental management and monitoring measures; a conclusion justifying the project on economic, social and environmental grounds, taking into consideration whether the project is consistent with the objects of the Environmental Planning & Assessment Act 1979; and a signed statement from the author of the Environmental Assessment, certifying that the information contained within the document is neither false nor misleading.
