Residential Subdivision at Lot 46 DP 28008, and Lots 1, 4, and 7 DP 270466 – Seaside Boulevarde, Fern Bay – Port Stephens local government area.

Modification:

06 0250 MOD 5 involving:

- the division of Stage 8 in two individual stages (Stage 8A & 8B);
- amendments to the provision of infrastructure and services to align with the new staging sequence; and
- minor amendments to the subdivision and road network layout.

SCHEDULE 2

The project approval as described in Schedule 1 is modified as follows:

(a) Following the definition "Regulation" and before the definition "Subject Site" insert new definition under Part C – Definitions as follows:

Stages 1 to 3 refers to those stages approved under Part 4 of the *Environmental Planning and Assessment Act 1979* by the NSW Land and Environment Court on 29 September 1997.

(b) Delete Condition A2 and replace with new Condition A2 as follows:

A2 Staging

Stages 1 to 3 are the subject of separate approvals issued by other authorities. The project is to be constructed in 18 stages, generally as follows:

- (1) Stage 4 comprises:
 - (c) Clearing, earthworks, roadwork, stormwater, and landscaping as well as servicing provisions for sewer, water supply, power and communications;
 - (d) 51 lots;
 - (e) Construction of sewer pump station P4;
 - (f) Construction of a shared footway/cycleway from the bus shelter in front of Bayway Village to the intersection of Seaside Boulevard and Nelson Bay Road;
 - (g) Establishment of Aboriginal Heritage Reserve (R3);
- (2) Stage 5 comprises:
 - (a) Clearing, earthworks, roadwork, stormwater, and landscaping as well as servicing provisions for sewer, water supply, power and communications;
 - (b) 51 lots;
- (3) Stage 6 comprises:
 - (a) Clearing, earthworks, roadwork, stormwater, and landscaping as well as servicing provisions for sewer, water supply, power and communications;
 - (b) 37 lots, including 1 commercial lot;
 - (c) Construction of a sewer pump station P5;
 - (d) Construction of infiltration basin 6;
 - (e) Construction of unnamed park (R6), including recreation facilities.
- (4) Stage 7 comprises:
 - (a) Clearing, earthworks, roadwork, stormwater, and landscaping as well as servicing provisions for sewer, water supply, power and communications;
 - (b) 31 lots;
- (5) Stage 8A comprises:
 - (a) Clearing, earthworks, roadwork, stormwater, and landscaping as well as servicing provisions for sewer, water supply, power and communications;
 - (b) 47 lots;
 - (c) Construction of Banksia Park (R4), including recreational facilities.

(6) Stage 8B comprises:

- (a) Clearing, earthworks, roadwork, stormwater, and landscaping as well as servicing provisions for sewer, water supply, power and communications;
- (b) 17 lots;

(7) Stage 9 comprises:

- (a) Clearing, earthworks, roadwork, stormwater, and landscaping as well as servicing provisions for sewer, water supply, power and communications;
- (b) Construction of sewer pump station P7;
- (c) 28 lots;
- (d) Construction of conveyance swale to infiltration area 5;

(8) Stage 10 comprises:

- (a) Clearing, earthworks, roadwork, stormwater, and landscaping as well as servicing provisions for sewer, water supply, power and communications;
- (b) 1 superlot;

(9) Stage 11 comprises:

- (a) Clearing, earthworks, roadwork, stormwater, and landscaping as well as servicing provisions for sewer, water supply, power and communications;
- (b) 20 lots;

(10) Stage 12 comprises:

- (a) Clearing, earthworks, roadwork, stormwater, and landscaping as well as servicing provisions for sewer, water supply, power and communications;
- (b) 26 lots, including 1 superlot;

(11) Stage 13 comprises:

- (a) Clearing, earthworks, roadwork, stormwater, and landscaping as well as servicing provisions for sewer, water supply, power and communications;
- (b) 12 lots, including 4 superlots;
- (c) Construction of swale to infiltration area 4;

(12) Stage 14 comprises:

- (a) Clearing, earthworks, roadwork, stormwater, and landscaping as well as servicing provisions for sewer, water supply, power and communications;
- (b) 22 lots, including 2 superlots;
- (c) Northern extension of Seaside Boulevard, including an intersection with Nelson Bay Road (northern intersection);
- (d) Construction of Corymbia Park (R5), including recreation facilities;

(13) Stage 15 comprises:

- (a) Clearing, earthworks, roadwork, stormwater, and landscaping as well as servicing provisions for sewer, water supply, power and communications;
- (b) 32 lots, including 1 superlot;

(14) Stage 16 comprises:

- (a) Clearing, earthworks, roadwork, stormwater, and landscaping as well as servicing provisions for sewer, water supply, power and communications;
- (b) 14 lots, including 5 superlots;

(15) Stage 17 comprises:

- (a) Clearing, earthworks, roadwork, stormwater, and landscaping as well as servicing provisions for sewer, water supply, power and communications;
- (b) 39 lots;

(16) Stage 18 comprises:

- (a) Clearing, earthworks, roadwork, stormwater, and landscaping as well as servicing provisions for sewer, water supply, power and communications;
- (b) 16 lots, including 4 superlots;

(17) Stage 19 comprises:

- (a) Clearing, earthworks, roadwork, stormwater, and landscaping as well as servicing provisions for sewer, water supply, power and communications;
- (b) 11 lots, including 5 superlots and 1 commercial lot (lot 383);
- (c) Construction of drainage swale to infiltration area 1;

(18) Stage 20 comprises:

- (a) Clearing, earthworks, roadwork, stormwater, and landscaping as well as servicing provisions for sewer, water supply, power and communications;
- (b) 18 lots, including 6 superlots;
- (c) Construction of unnamed park (R2), including recreation facilities.

The scope and extent of works within each stage of this project as outlined above may be varied due to market conditions and servicing constraints as agreed to by Council.

(c) Delete Condition A3 and replace with new Condition A3 as follows:
