Subject: Pink Nodding Orchid Assessment – Casuarina Town Centre, Tweed Coast Road, Casuarina, Tweed LGA

The Department received a Pink Nodding Orchid Assessment of the Casuarina Town Centre site, prepared by Cardno Principal Ecologist John Delaney and dated 24 June 2010.

As a requirement of Condition B3 of Major Project 06_0258, a study of the site is to be undertaken by a suitably qualified orchid specialist, and the results of the study submitted for approval to the Department of Planning and the Department of Environment, Climate Change and Water prior to the issue of a Construction Certificate.

I note that as part of the assessment, targeted surveys were undertaken at the site during the flowering season and no species were observed during these surveys. The impact mitigation and management recommendations outlined in the assessment are considered appropriate in managing any potential disturbance of undetected species once vegetation clearing and earthworks commence on the site.

It is therefore considered that the Pink Nodding Orchid Assessment submitted to the Department satisfactorily addresses the requirements of Condition B3, and is subsequently approved by the Department.

RE: CONDITION B3 – PINK NODDING ORCHID ASSESSMENT FOR CASUARINA TOWN CENTRE, (MP 06_0258) LOT 223 DP 1048498 TWEED COAST ROAD, CASUARINA

Thank you for your email to Kelly Roche on 20 July 2010 in which you provided the Department of Environment, Climate Change and Water (DECCW) with a copy of the Pink Nodding Orchid Assessment prepared by John Delaney of Cardno Gold Coast for consideration and approval. It is noted that this assessment was prepared in order to satisfy one of the conditions of approval imposed by the Department of Planning in relation to the Casuarina Town Centre development.

DECCW notes that there are two main elements to the condition of approval (B3 Flora and Fauna), requiring an initial assessment of potential habitat for Pink Nodding Orchid (*Geodorum densiflorum*) within the development footprint, followed by a targeted survey to determine presence or absence of the species within potential habitat areas. DECCW has reviewed the assessment report submitted for this species and is satisfied that the assessment is adequate and that management recommendations made by Cardno in respect of the species are appropriate.

It is further requested that, should any Pink Nodding Orchid specimens be translocated as part of the works as recommended in the assessment report, DECCW be provided with the details of the numbers and locations of all translocated individuals within three months of translocation occurring. This information will be added to the NSW Wildlife Atlas database. Appropriate monitoring and maintenance of any translocated specimens should also be implemented. Reference is made to the "Guidelines for translocation of threatened plants in Australia" (2nd Ed. ANPC 2004) if you require further information and guidance in relation to plant translocation.
