Introduction

This Section 75W Application is submitted on behalf of the Indigenous Land Corporation (ILC) for the National Indigenous Development Centre (NIDC) Major Project 06_0267.

The application incorporates proposed design modifications to Building F to accommodate alternate facility operator requirements.

Existing Consent

On 25 October, 2007, the Minister for Planning granted development consent for the NIDC in Redfern, Sydney (Major Project Approval No. 06-0267).

The Site

The proposed development is located on the site of the former Redfern Public School, bounded by George Street to the east, Phillip Street to the south and Cope Street to the west. Renwick Street forms a cul-de-sac at the northern boundary of the site, its vehicle connection through to Phillip Street having been physically closed some years ago.

Proposed Amendments

ILC seeks approval from the Minister for Planning for modifications to Major Project 06-0267 pursuant of Section 75W of the Environmental Planning and Assessment Act, 1979 (EP&A Act). The proposed modifications are summarised as follows:

- modifications to the George Street façade of Building F; and
- the addition of amenity and first aid facilities to the pool terrace of Building F.
