 - 1.1 The Proponent shall carry out the project generally in accordance with the:

a) Major Projects Application 07_0059;

- b) Banora Point Upgrading the Pacific Highway Environmental Assessment (volumes 1, 2 and 3), prepared by Parsons Brinckerhoff Australia Pty Ltd and dated February 2008;
- c) Banora Point Upgrading the Pacific Highway Environmental Assessment Submissions Report, prepared by Parsons Brinckerhoff Australia Pty Ltd and dated July 2008, including the revised Statement of Commitments contained therein;

d) Modification Application dated 1 October 2009 (7_0059 MOD 1) and request for modification dated 3 September 2009;

- e) Modification Application dated 23 October 2009 (7_0059 MOD 2) and request for modification dated 23 October 2009; and
- f) the conditions of this approval.
- 2. Replacing existing condition 1.2 with new condition 1.2, as follows:
 - 1.2 In the event of an inconsistency between:
 - a) the conditions of this approval and any document listed from condition 1.1a) to 1.1e) inclusive, the conditions of this approval shall prevail to the extent of the inconsistency; and
 - b) any document listed from condition 1.1a) to 1.1e) inclusive, and any other document listed from condition 1.1a) to 1.1e) inclusive, the most recent document shall prevail to the extent of the inconsistency.
- 3. Replacing condition 1.6 with the following:
 - 1.6 The Proponent may elect to construct the Project in stages provided construction is consistent with the conditions of approval. Where stages are proposed, the Proponent shall submit a Staging Report to the Director General eight (8) weeks prior to construction commencing, or as otherwise agreed by the Director General, which:
 - a) describes the stages; and
 - b) identifies how the conditions of approval will be addressed across and between the stages of the project.
