- 5. In condition 2 of Schedule 2, delete all words after "EA;" (with the exception of the notes); and insert the following:
 - (b) Modification 1;
 - (c) statement of commitments; and

- 6. Delete condition 13 of Schedule 2 and insert the following:

Section 94 Contributions

13. The Proponent shall pay contributions to Council for the upgrade and maintenance of roads in accordance with the *Mulwaree Shire – Development Contributions Plan 2003-2008*.

The contributions during Stage 2 transport shall be paid at \$0.0313 per kilometre per tonne of product transported by the project on all Council roads, to be paid from the commencement of Stage 2 transport.

Notes:

- contributions shall be indexed from 19 May 2009 in accordance with the Goulburn Mulwaree Section 94 Contributions Plan 2009.
- contributions shall be paid annually and in arrears.
- 7. Delete condition 34(b) of Schedule 3 and insert the following:
 - (b) deleted;
- 8. In condition 34(c) of Schedule 3, replace "Brayton Roadf" with "Brayton Road".
- 9. In the second note to condition 34 of Schedule 3, delete "with these costs applied against the section 94 contribution in Condition 13 of Schedule 2".
- 10. In Schedule 4 and Appendix 9, delete all references to "Appendix 9" and replace with "Appendix 8".
- 11. Delete condition 3 of Schedule 5 and insert the following:

Incident Reporting

- 3. At the earliest opportunity, the Proponent shall notify the Director-General and any other relevant agencies of any incident that has caused, or threatens to cause, material harm to the environment. For any other incident associated with the project, the Proponent shall notify the Director-General and any other relevant agencies as soon as practicable after the Proponent becomes aware of the incident. Within 7 days of the date of the incident, the Proponent shall provide the Director-General and any relevant agencies with a detailed report on the incident, and such further reports as may be requested.
- 12. Delete condition 7 of Schedule 5 and insert the following:
 - 7. Within 3 months of submitting a copy of the audit report to the Director-General, the Proponent shall review and if necessary revise the sum of the Vegetation Offset Bond established under condition 31 of schedule 3. This review shall consider:
 - (a) the effects of inflation;
 - (b) any changes to the total area of disturbance; and
 - (c) the performance of the vegetation offsets against the completion criteria of the Rehabilitation and Vegetation Offset Management Plan,

to the satisfaction of the Director-General.

Revision of Strategies, Plans & Programs

- 7A. Within 3 months of the submission of an:
 - (a) incident report under condition 3 above;
 - (b) AEMR under condition 4 above;
 - (c) audit report under condition 5 above; and
 - (d) any modifications to this approval,

the Proponent shall review, and if necessary revise, the strategies, plans, and programs required under this approval to the satisfaction of the Director-General.

Note: This is to ensure the strategies, plans and programs are updated on a regular basis, and incorporate any recommended measures to improve the environmental performance of the project.

13. Delete conditions 9 and 10 of Schedule 5 and insert the following:

- 9. For the duration of the project, the Proponent shall:
 - (a) make the following information publicly available on its website:
 - the documents referred to in condition 2 of schedule 2;
 - all relevant statutory approvals for the project;
 - all strategies, plans and programs required under the conditions of this approval;
 - a comprehensive summary of the monitoring results of the project, reported in accordance with the specifications in any approved plans or programs required under the conditions of this or any other approval;
 - a complaints register, which is to be updated on a monthly basis;
 - minutes of CCC meetings;
 - the AEMRs required under this approval;
 - any independent environmental audit of the project, and the Proponent's response to the recommendations in any audit;
 - any other matter required by the Director-General; and
 - (b) keep this information up-to-date,

to the satisfaction of the Director-General.

- 14. In Appendix 1: Schedule of Land, delete all words after "Crown public road;" and insert "Hume Highway intersection with Red Hills Road."
- 15. In Appendix 3: Statement of Commitments, in the first dot point in Section 1.2 Traffic, delete ", at the Brayton Road and George Street intersection (new roundabout)".
