Hi Roy

My comments are below:

1. As per the attached plan, existing Lot 5 will be subdivided (modification) into two - known as Lot 71 and Lot 72. At present, Lot 5 is currently fed by D1 of S5082. This supply need to be separated into two, serving one for Lot 71 and other for Lot 72, with easement.
2. Also, existing substation S5082 requires easement.
3. Any additional load connection in the future from RRC will require new kiosk, which will be a contestable project and funded by customer.
4. Further, depending on the load, Lot 71 and 72 may require two separate substations (funded by customer) located their lots with the establishment of easement.

Hope the above comments are helpful.
