Describe the proposed modification

The following modification to the Approved Project (Stages 1 and 2) is proposed: Addition of a new 330kV transmission line connecting the Bamarang Gas Turbine Facility to the existing Transgrid Kangaroo Valley-Canberra 330kV Transmission Line (Line 6), located approximately five kilometres to the west of the facility. The modification needs to allow for the construction a new 330kV transmission line as part of either Stage 1 or Stage 2 of the Approved Project, without removing the opportunity to construct and operate the 132kV transmission line that was approved as part of the

Concept Approval and Project Approval for Stage 1.
